MUST BE SUBMITTED AT TIME OF REGISTRATION

The student, and the parent/guardian if the student is under 18, acknowledge and agree to the following terms in order to participate in the Northwest Georgia Regional Science & Engineering Fair (RSEF).

Participant Release and Agreement

I hereby release, absolve and discharge Georgia Highlands College, and their representatives, employees and agents from any claim arising from my child's participation in the Northwest Georgia Regional Science & Engineering Fair.

In the event of an emergency, I acknowledge that the staff and volunteers will attempt to reach me at the contact information below to obtain my consent to medical treatment, if necessary. However, by operation of this permission document, I authorize the staff & volunteers to obtain expedient and proper treatment to assure the health and well-being of my child. If I am unable to be reached or if the situation deems necessary, 911 Emergency will be called.

I acknowledge and agree that I will be responsible for any medical expenses, which may be incurred as a result of an accident or injury during the activities of the RSEF, beyond routine first aid expenses.

Students are responsible for their own electronic devices. I understand that the staff and volunteers are not responsible for any loss or damage to a participating student's possessions or property during the RSEF.

Student Requirements:
